MINUTES ISABELLA COUNTY BOARD OF COMMISSIONERS August 16, 2016

The Isabella County Board of Commissioners was called to order at 7:00 p.m., by Vice Chairperson David Ling in the Commission Chambers on the above date.

It was moved by Commissioner Moreno and seconded by Commissioner Jaloszynski to approve the agenda as presented. Motion Carried.

PRESENTATIONS AND SPECIAL REPORTS:

1. FY 2017 Isabella County Commission on Aging:

It was moved by Commissioner Haupt and seconded by Commissioner Jaloszynski to approve the FY 2017 budget millage for the Isabella County Commission on Aging at 0.88 of one mill. The motion carried with 5 yeas and 0 nays. Yeas: Commissioners Haupt, Jaloszynski, Horton, Moreno and Ling. Nays: None.

2. FY 2017 Isabella County Medical Care Facility:

It was moved by Commissioner Haupt and seconded by Commissioner Horton to approve the FY 2017 budget millage for the Isabella County Medical Care Facility at 0.7 of one mill. The motion carried with 5 yeas and 0 nays. Yeas: Commissioners Haupt, Jaloszynski, Horton, Moreno and Ling. Nays: None.

3. FY 2017 Isabella County Parks and Recreation:

4. FY 2017 Isabella County Transportation Commission:

It was moved by Commissioner Horton and seconded by Commissioner Moreno to approve the FY 2017 budget millage for the Isabella County Transportation Commission at 0.862 of one mill.

2. Human Rights Committee - CMU Representative: Vice Chairperson's request for nominations for one opening on the Human Rights Committee for a Central Michigan University representative for a 3-year term ending September 1, 2019 or until a successor is appointed. Commissioner Haupt nominated Maureen N. Eke. Vice Chairperson Ling asked for nomination 3 times. It was moved by Commissioner Haupt and seconded by Commissioner Jaloszynski to close nominations and cast a unanimous ballot for Maureen N. Eke. Motion Carried.

3. Human Rights Committee-At-Large:

Vice Chairperson's request for nominations for two openings on the Human Rights Committee for a member-at-large representative for a 3-year term ending September 1, 2019 or until a successor is appointed.

Vice Chairperson Ling asked for a roll call vote. Haupt: Swift, Jaloszynski: Swift, Horton: Swift, Moreno: Swift, Ling: Swift. Anne M. Swift received 5 votes. Anne M. Swift was declared appointed.

Opening No. 2: Commissioner Moreno nominated Andrea Christopher. Commissioner Haupt nominated Wendy Hovey. Vice Chairperson Ling asked for a roll call vote. Haupt: Hovey, Jaloszynski: Hovey, Horton: Hovey, Moreno: Christopher, Ling: Hovey. Andrea Christopher received 1 vote. Wendy Hovey received 4 votes. Wendy Hovey was declared appointed.

4. Human Rights Committee-At-Large:

Vice Chairperson's request for nominations for one opening on the Human Rights Committee for a member-at-large representative to complete a 2-year term ending September 1, 2017. Commissioner Moreno nominated Matt Mertz. Commissioner Haupt nominated Karen Rau. Vice Chairperson Ling asked for a roll call vote. Haupt: Rau, Jaloszynski: Rau, Horton: Rau, Moreno: Mertz, Ling: Rau. Karen Rau received 4 votes. Matt Mertz received 1 vote. Karen Rau was declared appointed.

Human Resources and Public Works Committee:

1. Resolution No. 16-07-01 Beckett Drain:

WHEREAS, the Beckett Drain ("Drain") is a county drain, and the Beckett Drain Drainage District ("Drainage District") is a drainage district, both of which are duly established under the Michigan Drain Code, MCL 280.1 *et seq.* ("Drain Code"), located entirely within the City of Mt. Pleasant, and having no outstanding indebtedness or contractual liability; and

WHEREAS, the City of Mt. Pleasant wishes to obtain jurisdiction and control of the Drain and Drainage District; and

WHEREAS, the City has been advised and recognizes that, as provided for by the Drain Code, upon relinquishment of the Drain and Drainage District to the City, the City will assume all jurisdiction and control of the Drain and Drainage District and be responsible for their maintenance and operation and all costs attendant thereto.

WHEREAS, subject to terms and conditions set forth in a Beckett Drain and Drainage District Relinquishment Agreement and provided that all requirements of Section 395 of the Drain Code, same being MCL 280.395, have been met, the Isabella County Drain Commissioner is

agreeable to relinquishing jurisdiction of the Drain and Drainage District to the City; and

WHEREAS, Section 395 of the Drain Code requires that before the relinquishment of the Drain and the Drainage District to the City can occur, a majority of the members of the County Board of Commissioners must approve the relinquishment.

NOW THEREFORE BE IT RESOLVED that, pursuant to Section 395 of the Drain Code, MCL 280.395, the County of Isabella hereby approves the assumption of jurisdiction and control over Drain and Drainage District from the Isabella County Drain Commissioner to the City of Mt. Pleasant.

It was moved by Commissioner Moreno and seconded by Commissioner Haupt to adopt Resolution No. 16-07-01 approving the relinquishment of the Beckett Drain from the Drain Commissioner to the City of Mt. Pleasant, and authorize the Board Chair to sign the same. The motion carried with 5 yeas and 0 nays. Yeas: Commissioners Haupt, Jaloszynski, Horton, Moreno and Ling. Nays: None.
