

ADMINISTRATIVE ORDER 1997- 8

ISABELLA COUNTY TRIAL COURT
APPOINTMENT OF DEPUTY REGISTER OF PROBATE

1. DATE OF ORDER: April 22, 1997

PRESENT: Paul H. Chamberlain, Chief Judge

IT IS ORDERED THAT:

2. Wendy S. Yost is appointed Deputy Register of the Probate, Isabella Trial Court, for the County of Isabella effective April 22, 1997.

3. Pursuant to MCR 8.301, Wendy S. Yost, as Deputy Register of Probate, shall have the authority, until further Order of the Court, to do all acts required of the Probate Judge except judicial acts in a contested matter and acts forbidden by law to be performed by the Register of Probate. The powers of the Deputy Register of Probate shall include, but not be limited to, the following:


a. to set the time and place for hearings in all matter; take acknowledgments; administer oaths; sign notices to fiduciaries, attorneys, and sureties; sign citations and subpoenas; conduct conferences with fiduciaries required to ensure prompt administration of estates; and take testimony and conduct hearings as provided by law or court rule;

b. to sign the signature of the Probate Judge on Orders and Letters of Authority pursuant to MCR 5.602(B); and

c. to sign the signature of the Probate Judge on Orders for Interim Payment of Michigan Inheritance Tax, and on Michigan Inheritance Tax Orders.

IT IS FURTHER ORDERED that previous order dated October 7, 1988, file number 10,068, be rescinded as of April 22, 1997.
