Re: Four (4) subjects arrested for Larceny from a Person and Conspiracy to Commit Larceny from a Person One other subject has an outstanding warrant for the same charges, but is currently in Florida.

DATE AND TIME: January 12, 2013 at 2:10 a.m.

LOCATION: 3400 E. Deerfield Rd. (Deerfield Village Apartments), Union Township, Isabella County

SUBJECTS ARRESTED:

- 1) **Daniel John Abrahamson**, 20 years old from Northville, MI. He has been charged with one (1) count of Larceny from a Person (10 year felony) and one (1) count of Conspiracy to Commit Larceny from a Person (10 year felony and \$10,000 fine). He is a CMU student. Mr. Abrahamson has bonded out of the Isabella County Jail by posting \$10,000/10% cash-surety.
- 2) **Joseph Augustin Petrovich**, 19 years old from Farmington Hills, MI. He has been charged with one (1) count of Larceny from a Person (10 year felony) and one (1) count of Conspiracy to Commit Larceny from a Person (10 year felony and \$10,000 fine). He is a CMU student. Mr. Petrovich has bonded out of the Isabella County Jail by posting \$10,000/10% cash-surety.
- 3) **Dustin Edward Cochran**, 17 years old from Indian River, MI. He has been charged with one (1) count of Larceny from a Person (10 year felony) and one (1) count of Conspiracy to Commit Larceny from a Person (10 year felony and \$10,000 fine). He is not a CMU student. Mr. Cochran has bonded out of the Isabella County Jail by posting \$10,000/10% cash-surety.
- 4) **Kyle Elsen Weckesser**, 22 years old from East Lansing, MI. He has been charged with one (1) count of Larceny from a Person (10 year felony) and one (1) count of Conspiracy to Commit Larceny from a Person (10 year felony and \$10,000 fine). He is not a CMU student. Mr. Weckesser has bonded out of the Isabella County Jail by posting \$10,000/10% cash-surety.

SUBJECT NOT YET ARRESTED (CURRENTLY IN FLORIDA): **Elija Scott Burr**, 19 years old from Panama City, FL. He has an outstanding warrant for the following charges: One (1) count of Larceny from a Person (10 year felony) and one (1) count of Conspiracy to Commit Larceny from a Person (10 year felony and \$10,000 fine). He is not a CMU student.

INFORMATION: On Saturday, January 12, 2013 at approximately 2:10 a.m., 5 individuals conspired to, and ordered 8 sub sandwiches from Menna's Joint (1418 S. Mission St., Mt. Pleasant), even though they didn't have money to pay for them. They planned to take the food from the delivery person and take off running. They had the food delivered to an apartment at Deerfield Village, even though they didn't live there. They waited outside an apartment and when the delivery person arrived, they robbed him of the food and took off running away. The delivery person began chasing the individual that had the food and ended up tackling him. He held the suspect on the ground, but the suspect's friends returned to help. They were able to knock the delivery person off the suspect. They then grabbed the food and ran away once again. The delivery person was not injured during the incident.

The case remains under investigation.
