## **Coldwater Lake Family Park**

28-acre park on an all-sports lake including 98 modern campsites; 5 rustic cabins; modern, accessible bathhouse; sandy beach & swimming area; boating; modern boat launch; EZ Dock accessible kayak launch; fishing; sand volleyball; horseshoes; basketball; picnic areas with grills; 3 pavilions; accessible beach chairs and beach walkway, and accessible playground.



#### **Deerfield Nature Park**

591-acre park including 8 miles of trails, 10 rustic campsites (1-mile hike from parking lot), hand pump, sandy beach & swimming area, 4 canoe & kayak launches, 2 swinging bridges, covered bridge, 5 pavilions, picnic areas with grills, 2 artesian wells, fishing, sand volleyball, horseshoe pits, sledding hill, groomed cross-country ski trails in winter, two 18-hole disc golf courses and a new orienteering & land navigation course. No electricity. Pit toilets only. Open year-round.





#### **Gilmore Park**

1075 Queensway Drive, Weidman

Small picnic area, fishing platform, ice fishing access and pit toilet.



#### **Herrick Recreation Area**

6320 E. Herrick Rd., Clare In-season (989) 386-2010 Off-season (989) 317-4083

113-acre park including 73 campsites, 5 rustic cabins, modern bathrooms, accessible bathhouse, fishing ponds, boating (electric motor, canoe/kayak, etc. only), horseshoe pits, sand volleyball, sandy beach & swimming area, accessible walkway, picnic areas with grills, 2 large pavilions and 2 playgrounds. Located less than a mile from the Pere Marquette Rail-Trail.



# **Majeske Landing**

4674 W. Broomfield Rd.

2.5 acres along the Chippewa River. Public boat access to the Chippewa River and fishing opportunities.





# Lawrence A. McDonald Wildlife Sanctuary

On Business US-10 near Loomis

Follow Business US-10 east of Clare. Park is located on the south side of the road just west of the Pere Marquette Rail-Trail Loomis Trailhead.

11-acre wetland adjacent to the Pere Marquette Rail-Trail. Open Year-Round.



#### **Meridian Park**

3995 S. Meridian Rd.

153-acre park with Chippewa River flowing through and along trails. Fishing, 2 miles of hiking trails, picnic area with grill, pit toilet and canoe launch.



# Pere Marquette Rail-Trail (PMRT)

Along Business US-10 east of Clare, Trailhead at Loomis

Regional PMRT (100 miles Baldwin-Midland) with Isabella County portion 8.25 miles long.

14 ft. wide paved trail links to Midland and Clare County sections of the PMRT. Activities include bicycling, hiking, in-line skating and cross-country skiing. Pit toilet at Loomis Trailhead.
